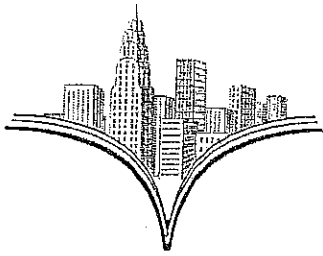
The credit consent form is needed for the following reasons:

1. If the parent elects to obtain a Parent Plus loan for the student, the school must run a credit check to see if Parent is approved for loan
 - a. If approved please Log onto WWW.Studentloans.gov and complete a Parent Plus Master Promissory Note.
2. If the Parent is denied we can raise the student's loan limit to possibly cover the unfunded balance.

To complete the Master Promissory Note online:

1. Go to www.pin.ed.gov to apply for a federal pin number
2. Go to www.studentloans.gov to complete a Parent Plus Master Promissory Note
