

**Academic Agreement
between
Adelphi University
and
Mildred Elley
for an
A.A. in Liberal Arts
LPN Pre-Nursing Plan of Study**

Agreement made this 12th day of January 2017 between Adelphi University, located at South Avenue, Garden City, New York 11530, and Mildred Elley, 25 Broadway, 16th floor New York, New York 10004 pursuant to which the parties agree to promote and strengthen scholarly and academic cooperation for the program outlined below.

I. Purpose of This Agreement

This agreement is to provide a program whereby students at Mildred Elley, upon completion of their License Practical Degree Program in Nursing, having obtained the required 2.5 grade point average stipulated by Adelphi, may continue their studies in Adelphi University's Associate of Arts in Liberal Arts, LPN Pre-Nursing Plan of Study. Upon successful completion of the Associate of Arts degree, students will apply to the School of Nursing and Public Health to complete their Bachelor of Science Degree in Nursing.

While the Adelphi University A.A. will be open also to applicants other than those from Mildred Elley, this agreement stipulates that applicants who graduate from Mildred Elley will be given priority consideration for admission at all of Adelphi's present and future campuses.

Adelphi University and Mildred Elley agree to adhere to the policies to which both institutions are committed concerning equal opportunity and nondiscrimination on the basis of race, creed, color, sex, sexual orientation, age, ethnicity, religion, national origin, or any other classifications that deprive the person of consideration as an individual, with a commitment by both institutions to abide by these principles in administering this agreement, in a manner that assures neither will impose criteria for participation or exchange of scholars or students that violate these principles of nondiscrimination.

II. Transfer of Credits

Mildred Elley students will be eligible to receive up to a maximum of 11 Prior Learning Credits which will transfer equivalent to the following credits at Adelphi University.

BIO 203 The Human Body I – 4 Credits

BIO 204 The Human Body II – 4 Credits

BIO 208 Microbiology – 3 Credits

The acceptable grade for transfer of science credits for the Nursing program is a C+ or better.

Other prior learning can be challenged for non-LPN coursework. A maximum of 30 possible Prior Learning credits will be allowed in this AA degree. Only courses completed with a grade of "C-" or higher will be accepted in transfer to the University.

III. Registration

Mildred Elley students who have been admitted to Adelphi University will be permitted to register during early registration at the same time as their Adelphi University counterparts.

IV. Communication

Adelphi University and Mildred Elley agree to cooperate in communicating with each other and with their respective constituents about the relationship between the two institutions. Faculty and staff at both institutions will share the information provided in this agreement with interested and qualified students. Adelphi University and Mildred Elley agree to provide counseling and advisement to students and prospective students about this partnership and the inherent benefits.

Mildred Elley will promote Adelphi University in any publications and/or websites that discuss Nursing School options and agreements. Mildred Elley will also distribute and make available any appropriate Adelphi University printed materials.

Administrators from Adelphi University will implement this agreement at Adelphi University and communicate changes to those parties to whom the information is pertinent. The same will be true at Mildred Elley.

V. Term and Termination

The term of this agreement shall commence on September 1, 2017 and the term shall be one academic year. For the purposes of this agreement the academic year begins September 1st and ends August 31st. Thereafter, this agreement shall be reviewed annually in September by the parties and may be amended, modified, or supplemented in writing by the Dean/Director of Mildred Elley and the Provost of Adelphi University. This agreement may be terminated on June 30th of any calendar year by either institution with one year written notice. However, any student enrolled in or accepted to the Program at the time of this agreement's termination will be entitled to complete the Program.

VI. Notices

All notices of any nature referred to in this Agreement shall be in writing and sent by registered or certified mail, postage prepaid, to the respective addresses set forth below, or to such other addresses as the respective parties may hereafter designate in writing:


