Other Uses of (a)(1) Institutional Portion of Funds.

- \$ 17,692 The institution hired Instructional Designers/Student Support Specialists due to the COVID-19 crisis. Due to the shutdown of campus operations we required additional assistance to design, develop and maintain online courses for our students. In addition, these positions were required to assist with online related student and faculty issues and to conduct periodic student and faculty training sessions related to the delivery of coursework online due to the pandemic.
- \$ 14,229 Shipping materials and shipping costs incurred due to the shutdown of campus operations. Students were not allowed to come to campus to pick up required materials for their online courses i.e. laptops, textbooks. These items were shipped to students homes so they could continue their studies online.
- \$ 4,290 Technology equipment required to be provided to faculty and staff to effectively transition to teach/work online effectively during the shutdown.
- \$ 925 Printed materials for students. Instructions on how to access their online classes as well as their online credentials were printed and mailed to students homes.
