**Higher Education Emergency Relief Fund II (HEERF II)**

**Mildred Elley HEERF II (CRRSAA) Financial Aid Grants to Students  
Quarterly Fund Report:**

**As of June 30, 2021**

- (1) Mildred Elley acknowledges that the institution signed and returned to the Department the Certification and Agreement on 2/01/2021.
- (2) Mildred Elley will use the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.
- (2) Mildred Elley has received \$2,002,214 from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.
- (3) The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of June 30, 2021 is \$0.
- (4) Mildred Elley estimates that approximately 1830 students are eligible to receive Emergency Financial Aid Grants under CRRSAA and ARP (a)(1) and (a)(4) programs.
- (5) As of June 30, 2021, zero students have received an Emergency Financial Aid Grant under CRRSAA and ARP (a)(1) and (a)(4) programs.
- (6) Mildred Elley will require students to submit an application and certify they will use the funds for their intended use. Mildred Elley will award grants based on the student's EFC, giving priority to students with exception need as demonstrated by their EFC.

(7) Mildred Elley will email eligible students the application/certification form with a 30-day deadline to complete and return to the institution for processing. Eligible students will be awarded a grant based on their EFC as reported on their 2020/2021 ISIR or 2021/2022 ISIR if they did not complete a 2020/2021 FAFSA. Students with a ZERO EFC will take priority. In addition, the following information will be emailed to eligible students.

On December 27, 2020, the President signed the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260. In total, the CRRSAA authorizes \$81.88 billion in support for education. The CRRSAA provides an additional \$22.7 billion for the Higher Education Emergency Relief Fund (HEERF).

### **How much HEERF II (CRRSAA) funding did Mildred Elley Receive?**

Mildred Elley has been allocated \$2,002,214 to provide emergency financial aid grants.

### **Who is eligible for a HEERF II emergency grant?**

There are three general eligibility requirements: 1) student must have been an enrolled student at Mildred Elley with attendance during the Summer I 2021 module, 2) student must be a U.S. citizen or an eligible non-citizen 3) student must have a 2020/2021 or 2021/2022 Institutional Student Information Report (ISIR) on file, which would be the result of filing the 2020/2021 or 2021/2022 FAFSA.

### **What are the requirements for awarding CRSAA Emergency Grant (HEERF II) to students?**

HEERF II (CRRSAA) regulations requires that institutions prioritize grant awards to students with exceptional need, such as students with a ZERO EFC.

Institutions may not (1) condition the receipt of financial aid grants to students on continued or future enrollment in the institution, (2) use the financial aid grants to satisfy a student's outstanding account balance, unless it has obtained the student's written (or electronic) affirmative consent, or (3) require such consent as a condition of receipt of or eligibility for the financial aid grant.

### **Do I have to apply for an emergency grant?**

Yes. To receive an emergency grant you must meet the eligibility requirements and complete and return an application and certification of the intended use of the funds.

## **How many students use their CRRSAA financial aid grants?**

CRRSAA grants may be used to pay for any component of the student's cost of attendance at Mildred Elley or for emergency costs that arise due to coronavirus, such as tuition, food, housing, course material, technology, health care or child care.

## **How will Mildred Elley disburse the CRRSAA grant funds?**

In adherence with the criteria established by the Department of Education, Mildred Elley will prioritize disbursement of grant funds to eligible students based on need which will be determined by the student's EFC. Mildred Elley will send the application/certification form to all eligible students via email to their Mildred Elley student email address. All application/certification forms MUST be completed and returned within 30 days from the date the email was sent to receive your grant funds. Mildred Elley will prioritize disbursements of the emergency grant funds to students who return their application/certification fully executed and have a ZERO EFC. Any unclaimed funds after all application/certifications are processed will be distributed evenly to the ZERO EFC students who returned their fully executed application. ## **How much emergency grant money will I receive?**

Your grant amount will be calculated based upon your EFC on your 2020/2021 ISIR or 2021/2022 ISIR if you did not submit a 2020/2021 FAFSA.

## **How will I receive my emergency grant?**

The student has the option to choose which method in which they wish to receive their funds on the application/certification form. They may choose to receive their emergency grant via check in the mail or to have the funds applied directly to their student account.

## **When will I receive my emergency grant?**

Application approvals will begin 30 days after the date the application/certification is sent. At that time student disbursements will be prioritized based on need which will be determined by their EFC.
