ARTICULATION AGREEMENT

Helene Fuld College of Nursing-Generic Bachelor of Science in Nursing And Mildred Elley's Medical Assistant A.O.S Degree Program

Helene Fuld College of Nursing hereby agrees to accept the graduates of Mildred Elley's Medical Assistant A.O.S. Degree Program into the Helene Fuld College of Nursing program of study leading to Bachelor of Science with a major in Nursing and Registered Nurse licensure under the following conditions:

- Helene Fuld College of Nursing will waive the following requirement:

 o Entrance examinations in reading, mathematics, science, and English.
- The applicant must have:
 - 1. The recommendation of Program Coordinator/Director
 - 2. Achieved B or better grade in every course within Mildred Elley to be exempted from the entrance examinations in reading, mathematics, science and English
 - 3. Submitted the application for admission within two years of graduation from Mildred Elley
- The applicant may transfer up to 17 credits from the MA program taken at Mildred Elley. All other admission and continuance criteria, as outlined in the catalog will also apply.
- Helene Fuld College of Nursing will only review applicants processed through Mildred Elley
- Students from Mildred Elley who apply directly to Helene Fuld College of Nursing, will be required to meet all requirements as stated in the Helene Fuld College catalog.
- Mildred Elley and Helene Fuld College of Nursing shall review course entrance criteria and student progress on a yearly basis.
- Applicants from Mildred Elley will be ranked based on GPA and the top 20 students will be granted admission per enrollment cycle (2 times a year).
- Helene Fuld College of Nursing agrees and acknowledges that Mildred Elley will pay no money to Helene Fuld College of Nursing for the services which the College will provide under this agreement.

- This agreement may only be modified or amended by mutual agreement of the parties in writing and any such modification or amendment will be attached to and become part of this agreement.
- The parties to this agreement will maintain their independent and separate identities with each having exclusive control of its own management, assets, and affairs. Neither party will by virtue of this agreement, assume any liability or obligation of the other party.
- Notice of the existence and terms of this Articulation Agreement may be placed on the websites, catalogs, and promotional materials of both institutions that are party to this agreement.
- This agreement may be terminated by either party upon written notice by the month of June. Such termination shall not affect the students presently enrolled pursuant to this agreement.
- This agreement constitutes the entire agreement of the parties and no other prior or contemporaneous agreement, oral or otherwise, regarding the subject matter of this agreement will be deemed to exist or bind any of the parties hereto, or to vary any of the terms contained herein.
